This is a follow up to PAA Order PSC-96-0636-FOF-TI 5-10-96 (copy attached) that approved the merger of LCI Telemagement Corp. (TI403) and LCI International Telecom Corp. (TI890). According to the ordering paragraphs if no protest(s) filed the docket would be closed, which it was; also it stated that upon consummation of the proposed merger LCI International Telecom Corp. shall notify Commission so that LCI Telemagement Corp.'s certificate could be canceled. Letter (copy attached) was received on 7-11-96 from Ms. Michelle Burgee of the company advising that the merger was effective on 5-28-96 and that LCI Telemagement is no longer in existence.

As of this date we have not had a memo from CMU and/or Legal advising to cancel their certificate. In order for me to "inactive" the company we must have a memo to that effect stating "certificate is now canceled." Please check into this for us, we do need to get this done, as when Fiscal sends out the next "regulatory assessment fee forms", they will be included in their mail out.
