Dear Mr. Charles Edge:

Grenlefe Utilities, Inc. (Grenlefe) application for water and wastewater certificate under grandfather rights requires additional information to fulfill requirements of Chapter 25-30.035, Florida Administrative Code (F.A.C.).


- 1) As required by Rule 25-30.035(6), F.A.C., the application must include proof of ownership. You must file a copy of proof of ownership of the utility facilities and land upon which the facilities are located. It appears the deed is for the entire 'Grenlefe' area. Staff also requires verification of corporate ownership. The warranty deed names Grenlefe Corporation as the deed holder, but the application is in the name of Grenlefe Utilities. Lastly, the deed also mentions an 'Exhibit A', consisting of 33 pages. Please provide this attachment.
- 2) As required by Rule 25-30.035(7), F.A.C., the application must be accompanied by a tariff. Please complete the entire enclosed water and wastewater tariffs.
- 3) The system map detailing the design of the physical properties, which make up the water and wastewater systems, does not meet Commission standards. The map included with the application does not mark the actual lines of the water and wastewater systems. As required by Rule 25-30.035(10), F.A.C., provide a system map that encompasses the entire system and adequately details the physical attributes of the water and wastewater system.
- 4) The map detailing the requested service territory does not meet Commission standards. As required by Rule 25-30.035(11), F.A.C., provide a territory map that clearly defines the territory requested and identically tracks the legal description.

5) The application was signed by the utility manager, Mr. Charles Edge. Florida Administrative Code requires a signature from a corporate officer or a letter of authorization allowing Mr. Edge to act on behalf of the utility.
