This Notice exempts this material from §119.07(1) of the Florida Statutes and §24(a), Art. 1 of the State Constitution and protects it from public disclosure. All of this information falls within Florida Statutes §364.183(3)(e), which defines the term "proprietary confidential business information" to include "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of that information." In a competitive business, any such knowledge obtained about a competitor can be used to the detriment of the entity to which
