## PETITION OF FLORIDA POWER \& LIGHT COMPANY TO FURTHER EXTEND ITS BUILDSMARTTM PILOT PROGRAM

Florida Power \& Light Company ("FPL"), pursuant to Section 366.82(2), Florida Statutes (1995), hereby petitions the Florida Public Service Commission ("Commission") to extend FPL's BuildSmart ${ }^{\text {TM }}$ Pilot Program until final Commission action on FPL's Amended Petition For Approval Of BuildSmart ${ }^{\text {TM }}$ Program and allow FPL to recover reasonable and prudent expenditures for the BuildSmart ${ }^{\text {TM }}$ Pilot Program through FPL's Energy Conservation Cost Recovery ("ECCR") Clause. The grounds for this petition are:

1. FPL is an investor-owned electric utility regulated by the Commission pursuant to Chapter 366, Florida Statutes. FPL is subject to the Florida Energy Efficiency and Conservation Act ("FEECA"), Section 366.80-.85, 403.519, Florida Statutes (1995), and its ECCR Clause is subject to the Commission's jurisdiction. FPL is substantially affected thereby.
2. FPL's address is 9250 West Flagler Street, Miami, FL 33174. Correspondence, notices, orders and other documents concerning this Petition should be sent to:

3. In March 1993 the Commission approved the New Home Construction Research Project as part of FPL's Conservation Plan. Order No. PSC-93-0339-FOF-EG. The New Home Construction Research Project was a two year research project designed to investigate, quantify and determine the cost-effectiveness of the conservation opportunities available in the residential, detached, single-family, home construction market.
4. A significant part of the New Home Construction Research Project was the creation and offering of a BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program that has been used to evaluate the impact of education, inspections, and certification on new home construction energy-efficiency. In the BuildSmart ${ }^{\text {TM }}$ P:iot Program, FPL has educated builders and customers about energy-efficiency building practices and their benefits, performed new home inspections to verify installations, rated the homes for their energy efficiency, and provided certificates for qualifying new homes (homes that exceed Energy Efficiency Code requirements by more than $10 \%$-Bronze Certificates, $20 \%$-Silver Certificate, and $30 \%$-Gold Certificates). The Residential New Construction BuildSmart ${ }^{\text {TM }}$ Program Standards, previously provided to the Commission as part of a quarterly report, more fully explain the BuildSmart ${ }^{\text {TM }}$ Pilot Program and are attached as Appendix A.
5. FPL has been offering the BuildSmart ${ }^{\text {TM }}$ Pilot Program in Southwest Florida (Charlotte, Lee, Glades, Hendry and Collier counties). The pilot program has been well-received by builders and customers. As of September 30, 1996, ninety-five (95) builders have participated and five hundred and thirty-eight (538) homes have been certified (see Appendix B for a list of participating builders and home certification history).
6. FPL completed its New Home Construction Research Project and filed a final report with the Commission on June 1, 1995. The final report found that BuildSmart ${ }^{\text {TMM }}$ had proven preliminarily to be cost-effective.
7. Prior to filing its final report, FPL petitioned the Commission to extend FPL's BuildSmart ${ }^{\text {TM }}$ Pilot Program through December 31, 1995. FPL requested that its BuildSmart ${ }^{\text {TM }}$ activities in Southwest Florida be continued until a system-wide program could be established. The primary justification for the continued offering of BuildSmart ${ }^{\text {TM }}$ in Southwest Florida was program continuity. BuildSmart ${ }^{\text {TM }}$ had been well-received where it is offered, and there was significant momentum in those markets. Suspension of the BuildSmart ${ }^{\text {TM }}$ efforts until a new program could be rolled-out would have forfeited that momentum and adversely affected customer and building contractor acceptance. Therefore, FPL sought Commission approval to continue the BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program until FPL could seek and was granted approval of a system-wide BuildSmart ${ }^{\mathrm{TM}}$ Program. By Order No. 95-0611-FOF-EG, the Commission granted FPL's request to extend the BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program through December 31, 1995.
8. FPL filed a petition seeking Commission approval of a permanent BuildSmart ${ }^{\mathrm{TM}}$ Program on December 7, 1995. That petition was assigned Docket No. 951536-EG.
9. At the same time that FPL filed for approval of the permanent BuildSmart ${ }^{\mathrm{TM}}$ Program, FPL sought a further extension of the BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program until final Commission action in Docket No. 951536-EG. In Order No. PSC-96-0116-FOF-EG, the Commission granted a second extension of the BuildSmart ${ }^{\text {TM }}$ Pilot Program through March 30, 1996.
10. In February 1996 FPL filed a request for a third extension for the BuildSmart Pilot Program, since the schedule for the Permanent BuildSmart Program had been extended beyond

March 30, 1996. Once again FPL sought Commission approval of the extension of the BuildSmart Pilot Program until final Commission action in Docket No. 951536-EG. By Order No.PSC-96-0404-FOF-EG, the Commission granted a third extension of the BuildSmart Pilot Program through December 31, 1996.
11. In July 1996 FPL amended its petition for approval of the permanent BuildSmart ${ }^{\text {TM }}$ Program in Docket No. 951536-EG. FPL does not anticipate Commission proposed agency action on the permanent BuildSmart ${ }^{\mathrm{TM}}$ Program until some time in late 1996. A protest of such a proposed agency action order would extend final action on the BuildSmart ${ }^{\text {TM }}$ Program well into 1997 Therefore, FPL is filing this Petition to seek a further extension of its BuildSmart ${ }^{\text {TM }}$ Pilot Program in Southwest Florida until the Commission takes final action on FPL's petition in Docket No 951536-EG. FPL is prepared to continue submitting quarterly reports during this extension period
12. FPL seeks to recover the costs associated with the extension of its BuildSmart ${ }^{\text {TM }}$ Pilot Program after December 31, 1996 until the Commission takes final action in Docket No. 951536 EG. FPL estimates that the cost of extending its BuildSmart ${ }^{\mathrm{TM}}$ activities in Southwest Florida through December 31, 1997 would be $\$ 80,000$. These expenditures are in excess of the $\$ 6,750,000$ of costs originally estimated for FPL's New Home Construction Research Project and the additional amounts authorized in the three prior extensions of the BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program.
13. FPL believes that its BuildSmart ${ }^{\text {TM }}$ Pilot Program in Southwest Florida should continue until a system-wide program can be established. The primary justification for the continued offering of BuildSmart ${ }^{\text {TM }}$ in Southwest Florida is program continuity. BuildSmart ${ }^{\text {TM }}$ has been well-received where it is offered, and there is significant momentum in those markets Suspension of the BuildSmart ${ }^{T M}$ efforts until a new program can be rolled-out would forfeit that
momentum and adversely affect customer and building contractor acceptance. Therefore, FPL is seeking Commission approval to continue the BuildSmart ${ }^{\text {TM }}$ Pilot Program until FPL can seek and is granted approval of a system-wide BuildSmart ${ }^{\text {TM }}$ Program.
14. The continued offering of BuildSmart ${ }^{\mathrm{TM}}$ will help achieve the goals of FEECA and Commission Rule 25-17.001, Florida Administrative Code. BuildSmart ${ }^{\mathrm{TM}}$ has been shown to be cost-effective to both participating and nonparticipating customers. BuildSmart ${ }^{\mathrm{TM}}$ has also been demonstrated to be monitorable and to yield measurable results. Therefore, it satisfies the Commission's criteria for approval and cost recovery.

WHEREFORE, FPL respectfully petitions the Commission (1) to extend the BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program in Southwest Florida until the Commission takes final action in Docket No. 951536EG, FPL's petition for approval of a permanent BuildSmart ${ }^{\text {TM }}$ Program for system-wide implementation, and (2) allow FPL to recover through its ECCR clause reasonable and prudent expenditures for the extended BuildSmart ${ }^{\mathrm{TM}}$ Pilot Program activities.

## Program Oblective

The objective of the BuildSmart Program is to encourage energy conservation through the building of energy efficient residential new construction. The purpose of these standards is to instruct builders in the FPL BuildSmart process.

## Utility's Requirements for Program Participation by Bullders

1. Each participating builder must enter into a BuildSmart Program Contract with FPL covering the time period and territory served by the participating builder. The contract must be signed by the general building contractor.
2. Builders must comply with all national, state and local codes and ordinances.
3. The BuildSmart Program applies only to residential single-family detached dwellings.
4. Dwellings must be serviced by FPL and located within the BuildSmart service territory (see Exhibit F).
5. All eligible BuildSmart homes must be completed on or after January 1, 1994.
6. The dwelling must have whole house cooling which may be supplied by a central cooling system or by a combination of individual room units.
7. Builders shall provide the following data for each home to be certified in the program:

- BuildSmart Notification Form \{See Exhibit A\}
- Energy Performance Index (EPI) \{See Exhibit B\}
- HVAC Manual J Load Calculations \{See Exhibit C\}
- Floor and Elevation Plans

8. The builder shall correct any deficiency with the inspection as identified by FPL prior to BuildSmart certification of the home.
9. FPL reserves the right to verify each installation for which a BuildSmart Notification Form has been submitted.
10. FPL will be the final judge of whether the requirements of the BuildSmart Program have been met.
11. FPL reserves the right to modify or terminate these program standards and procedures for this program at any time with ten (10) days written notice to the participating FPL BuildSmart builders.

## Details on How BuildSmart homes Will Be Processed by Builders

1. Builder will submit to FPL for each home:

- BuildSmart Notification Form,
- Energy Performance Index(EPI),
- HVAC Manual J Load Calculations, and
- Floor and Elevation Plans.

2. Builder will notify FPL to perform Mid-point Inspection.

- Prior to drywall,
- After air conditioning duct work is installed, and
- Prior to ceiling insulation if possible.

3. Builder will notify FPL to perform Final Inspection immediately prior to certificate of occupancy. Once homes have passed the Final Inspection, builders will be awarded the appropriate BuildSmart Certificate and Medallion.

- Review EPI Calculation
- Review Manual J Load Calculation
- Review Floor and Elevation Plans

Mid-point FPL Inspection:

- Duct Air Tightness Testing
- Air, Moisture and Thermal Barriers
- Glass, Floor and Wall Area and Orientation
- Framing and Overhang

Final FPL Inspection:

- Infiltration Practice
- Mechanical Equipment Verification

Heating System
Cooling System
Hot Water System

- HVAC Credits
- Hot Water Credits
- EPI Verification
- Manual J Verification


## Technical Specifications of Eliaibility

1. Builder will comply with all national, state and local codes pertaining to residential new construction.
2. Houses submitted as BuildSmart will achieve an EPI of 90 or below and will fall under three levels:

| BuildSmart Level | Description |
| :---: | :--- |
| Bronze | $90-81 \mathrm{EPI}$ |
| Silver | $80-71 \mathrm{EPI}$ |
| Gold | 70 or below EPI |

3. HVAC Manual J load calculations will comply with all national, state and local codes pertaining to the installation and operation of HVAC equipment.
