Dear Mr. Potter:

On December 17, 1996, the Commission voted on and approved staff's recommendation dated December 5, 1996. A Proposed Agency Action (PAA) order is scheduled to be issued twenty days from the date of the Commission's vote. If no protests have been filed by the end of the protest period, which is 21 days from the date the PAA order is issued, the rate and charges approved by this Commission will become final. However, the utility must first submit revised tariff pages for staff approval before the utility will be allowed to implement the rate changes.

	In addition, staff has reviewed the utility's tariff and finds that only the rate schedules need to be revised. In order to expedite the tariff revision process, the utility should file all
