## GTE FLORIDA INCORPORATED'S NOTICE OF INTENT TO SEEK CONFIDENTIAL CLASSIFICATION

Pursuant to Commission Rule 25-22.006(6)(c), GTE Florida Incorporated (GTEFL) notifies the Commission of its intent to seek confidential classification for certain costing information produced in response to Order No. PSC-97-0064-FOF-TP (Order).

This notice exempts the documents from section 119.07(1) of the Florida Statutes and section 24(a), Article 1 of the Florida Constitution and protects it from public disclosure. All of this information falls within Florida Statutes section 364.183(3)(e), which defines the term "proprietary confidential business information" to include "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of that information." In a competitive business, any such knowledge obtained about a competitor can be used to the detriment of the entity to which it pertains. This unfair advantage skews the operation of the market, to the ultimate detriment of the consumer.

GTEFL will file a request for permanent protective order 21 days from the date of this Notice.
