4. Financial Qualifications

Attached hereto as Exhibit 4 is a copy of the applicant's parent Corporation, Quintel Entertainment, Inc.'s 1996, financial statements for fiscal year ending November 30, 1996. These financial statements demonstrate that Quintelco has the financial ability to provide the services that it hereby requests authority to offer to the public.

5. Current Business Transactions

Quintelco currently provides resold interexchange telecommunications services in Illinois, New Jersey, New York, California, Delaware, Georgia, and Kansas.

Quintelco is in the process of petitioning the remaining States for local and long distance resale authority. In no instance has an application been denied or rejected.

6. The Services to be Offered by Applicant

Quintelco intends to subscribe to and resell all forms of telephone service including interexchange and local services in the State of Florida including: local dial tone services, Message Telephone Service, Wide Area Telephone Service, WATS-like services, Foreign Exchange Service, private lines, tie lines, access service, cellular service, local switched service and other services and facilities of communications common carriers and other entities. Quintelco intends to provide service to both residential and business class customers throughout the entire State of Florida.

7. Communications network and technical support

Quintelco submits this application to provide non-facilities-based resale of telecommunications services that will be provided over the networks of incumbent long distance and local exchange carriers that it has contracted with. Quintelco neither owns, nor leases equipment or facilities used for the transport of telecommunications services. Therefore, applicant is solely dependent on the technical capabilities of Florida's incumbent long distance and local exchange carriers.

Quintelco has only recently contacted the incumbent carriers in Florida. Negotiations are to begin shortly.

8. How competition will be enhanced if the applicant is allowed to enter the market.

Quintelco proposes to acquire and resell various voice and data communications services offered by communications common carriers, and to package and provide these services for the specialized functions and needs of its customers. In particular, services will be acquired from underlying communications common carriers at bulk rates and will be resold to applicant's

customers, so that customers will benefit from reduced pricing. The experienced management, technical, and operations expertise of the Quintelco team will enable Quintelco to begin offering competitive high-quality service immediately upon the grant of the authority requested herein.

In addition to reduced pricing, the introduction of Quintelco services will promote competition and lead to greater efficiencies and more rapid introduction of new technologies in the use of telephone service. Thus, Commission grant of this application will significantly serve the public interest through enhanced competition in the market for local and interexchange services through the addition of a well managed new entrant into the local market.

9. Formal Complaints

No officer, director, or shareholder, nor any of the Quintelco's business operations, have been involved in any formal complaint or other investigatory coefforcement proceeding.

10. Proposed Tariff

Quintelco's proposed tariff is attached hereto as Exhibit 5.
