GTE Card Services Incorporated d/b/a GTE Long Distance is the holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 4080, and Alternative Local Exchange Company Telecommunications Certificate of Public Convenience and Necessity No. 4819. On July 10, 1997, GTE Card Services Incorporated d/b/a GTE Long Distance filed an amendment to its application for authorization to transact business in Florida as a foreign corporation changing its name to GTE Communications Corporation. This name change was acknowledged by the Florida Department of State on July 11, 1997.

The company will do business under its new name, GTE Communications Corporation, and will no longer use a fictitious name in Florida. The use of this new name is only a name change, and does not involve any change in majority organizational control or other change in ownership.
