

VACATION LOCK FEE - This charge would be levied for turn off service requested for a vacation period.

RETURN CHECK FEE - This charge would be levied on all customers checks returned by the depository marked non sufficient funds or no such account.

LATE PAYMENT FEE - This charge would be levied for payments made after a bill becomes delinquent as defined by Rule 25-30.335(4).

VIOLATION RECONNECTION FEE - This charges would be levied prior to reconnection of an existing customer after disconnection of service for cause according to Rule 25-30.320(2), Florida Administrative Code, including a delinquency in bill payment.
