Kenarl, Inc. requests that the Protective Order specifically state that these documents be disclosed only to Staff members directly involved in this case, and that any pleadings or other filings that incorporate, reference or attach the document or any portion thereof be submitted under Seal.

As grounds for this motion, Kenarl states that this Financial Statement contains information which is required to be submitted to the Commission as part of Kenarl's Applications for Authority to Provide Interexchagne Telecommunications Service and Alternative Local Exchange Service within the State of Florida, however, this financial statement discloses information about private individuals who own a private, closely-held corporation, and whose financial information is maintained as highly confidential and proprietary.

Public disclosure of this information would serve no useful purpose and would interfere with the privacy of Mr. and Mrs. Adams.
