In support of this Petition, FPL states as follows:

1. The final \$20,629 Environmental Cost Recovery overrecovery for the period October 1996 - September 1997, was calculated in accordance with the methodology set forth in Schedule A-2 for the Fuel Cost Recovery Clause, attached to Order 10093 dated June 19, 1981. This calculation and the supporting documentation are contained in the prepared testimony of FPL witness K. Dubin, which is being filed together with the Petition and incorporated herein.

2. The adjusted net true-up for the period of an overrecovery of \$2,517,919 is the difference between the actual true-up of \$20,629 overrecovery and the estimated/actual true-up of \$2,137,290 overrecovery approved by the Commission at the August 1997 hearing.

WHEREFORE, Florida Power & Light Company respectfully requests
