

From Rainbow Springs Utilitis L.C.
To Residents/Property Owners, Rainbow Springs.
Re: Notice of Application for Extension of
Service Area.

As property owners in the Forest section of Rainbow Springs
in Marion County, we hereby register our objection to such
Application being granted to Rainbow Springs Utilities L.C.

Furthermore, in view of the intervening holidays insufficient
time has been made available to us to enable us to convene a
meeting of the interested property owners located in the
Forest area to review the impact of this proposal. We
therefore respectfully request that the Florida Public
Service Commission delays any formal action in this matter
until such meeting can be achieved.

At this juncture, it should be noted that we, and other
homeowners, have already spent thousands of dollars
installing wells, septic, and purification systems, to
provide adequate water, and disposal installations when
building our homes. We are perturbed that the proposed
systems might impact upon us by way of an initial expense,
and mandatory purchase by us of the facilities which we do
not require, and which could become an on-going financial
burden. It is upon the foregoing that we base our objection
since no protection of our rights appears to be involved.

We would be grateful for your earnest consideration of our
position, and thank you in anticipation of your attention.
