

On March 18, 1997, Florida Water Services Corporation ("Florida Water") filed a petition with the Florida Public Service Commission ("Commission") requesting approval of rates for Residential Wastewater Only ("RWO") service in all of Florida Water's service areas under the Commission's jurisdiction which did not have RWO rates. The RWO rate is a flat rate for customers who receive wastewater service from Florida Water, but who are not water customers of Florida Water.

On November 25, 1997, the Commission issued Order No. PSC-97-1503-FOF-SU approving the requested RWO rates. The rates will become effective for service rendered on or after the stamped approval date on the tariff sheets. The tariff sheets will be approved on February 10, 1998 after the affected RWO customers of Florida Water have received this notice.

The newly approved RWO rates are listed in the Rate Schedule on the reverse side of this notice.
