DISCUSSION OF ISSUES

Should Ms. Shirley Jones be named Telecommunications Access System Act (TASA) Advisory Committee?

RECOMMENDATION: Yes. (KING)

STAFF ANALYSIS: TASA allows the Advisory Committee to consist of up to ten members recommended by various organizations and named to the committee by the Commission.

On February 12, 1998, Ms. Joan Andrews, President of the Florida Association of Self Help for Hard of Hearing People, submitted a letter via e-mail (Attachment A, page 3) nominating Ms. Shirley Jones to the Committee. Ms. Jones fulfills the requirements of section 427.706(1) of the TASA law which addresses the necessary characteristics and qualifications one must have to become an Advisory Committee member. The appointment of Ms. Jones will bring the TASA Advisory Committee member total to eight. Accordingly, staff recommends that Ms. Jones be named to the TASA Advisory Committee.
