By Order No. PSC-97-1613-FOF-WU, issued on December 23, 1997, the Commission approved a transfer of plant facilities from SH Utilities, Inc. to Lindrick Service Corporation as a final agency action. The rate base amount was approved as a proposed agency action, with any objections due by January 13, 1998. The rate base determination was not protested.

The Commission also ordered Lindrick to file a warranty deed for plant sites within sixty days of the order. On February 16, 1998, Lindrick filed the specified warranty deed with the technical staff. This document is enclosed for inclusion in the docket file. Since submission of this document completes the filing instructions, this docket should be closed.
