## JOINT ANNUAL REPORT OF CLAY ELECTRIC COOPERATIVE, INC. AND FLORIDA POWER CORPORATION

The Annual Status Report is to be filed with the Commission pursuant to Article VI.

Section 6.2 of the Territorial Agreement.

The transfer should have been complete by November 27, 1997, but there was a delay. The reason for delay is that the scope of the transfer is such that certain areas covered in the agreement make it extremely difficult for both companies to acquire the necessary easements and to build lines necessary to service the other company's customers. No customers have been negatively impacted by the delay, and no customers have complained due to the delay. All deposits are being refunded as the transfers take place.

There are thirty (30) remaining street lights to be transferred with fourteen (14) in Marion County and sixteen (16) in Columbia County. There are thirty-three (33) accounts remaining to be transferred in Marion County and forty-five (45) accounts remaining to be

transferred in Columbia County. We expect to have the transfers complete by the end of June, 1998.
