





An affidavit that the notice of actual application was given in accordance with Rule 25-30.030, Florida Administrative Code, by regular mail or personal delivery to each customer of the system. A copy of the notice shall accompany the affidavit.

Please see attached. Upon information and belief, Florida Water Services understands that Lake Suzy Utilities, Inc., is currently providing water service to one property within the proposed addition. That property has a street address of: 24358 Kingsway Circle, Arcadia, Florida 34266. According to the Charlotte County Property Appraiser's Office the mailing address for the owner of said property is: Robert B. and Sharon Helphenstine, Southwest Kingsway Circle, Arcadia, Florida 34266.

As there are no other customers in the proposed territory to be added and no "system" is in place, no other customers need be noticed in accordance with the rule.

It has recently come to the attention of Florida Water Services that the persons listed in the attached Amended Appendix S-2 own property in the proposed service territory addition. Florida Water is not currently providing service to these properties and does not know whether Lake Suzy Utilities, Inc. currently provides service. However, in an abundance of caution, Florida Water Services has provided these property owners with notice as stated in the Affidavit attached hereto. Notice was sent by certified mail to Mr. & Mrs. Helphenstine on February 18, 1998, as stated in the original Exhibit S.
