## AMENDATORY ORDER

On March 9, 1998, the Commission issued Order No. PSC-98-0375-FOF-EG, in Docket No. 970541-EG, acknowledging the Florida Apartment Association's withdrawal of its protest of our Proposed Agency Action Order No. PSC-97-1481-FOF-EG (PAA Order) and making the PAA Order final and effective. After issuance, a scrivener's error was noted. To correct this error, Order No. PSC-98-0375-FOF-EG is amended as follows:

- 1. On page 2, the phrase "It is further" will be added to the end of the second ordering paragraph.
- On page 2, a third ordering paragraph will be added and will read: "ORDERED that this docket shall be closed."

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-98-0375-FOF-EG is amended as set forth in the body of this Order. It is further
