Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Florida Administrative Code Rule 25-9.004 files this its Petition for Approval of a Building Energy-Efficiency Rating System Tariff, and in support thereof states:

1. Tampa Electric is an investor-owned electric utility operating under the jurisdiction of this Commission and serving retail Customers in Hillsborough and portions of Polk, Pinellas and Pasco Counties. The company's principal offices are located at 702 North Franklin Street, Tampa, Florida 33602.

3. A Building Energy-Efficiency Rating System (BERS) Audit is an energy analysis that may be performed, upon customer request, on new or existing single family residences. BERS Audits performed by Tampa Electric will be in compliance with Section 553.995, Florida Statutes, and Rules 9B-60.004(3) and (4) and 9B-60.005, Florida Administrative Code.

4. In accordance with 25-17.003(4)(a), Florida Administrative Code, Tampa Electric has developed a charge to assess applicable customers for BERS Audits. Through this petition, Tampa Electric is submitting the aforementioned charge for approval.

5. The proposed new tariff sheets (Original Sheet Nos. 3.250 and 3.251) are provided in standard format as Exhibit "A" to this petition. Also, legislative format versions of the proposed new tariff sheets are provided as Exhibit "B".

6. These additions to the tariff and the benefits to customers that they represent will enhance the service provided to the customers without affecting the cost of service to Tampa Electric or Tampa Electric's other customers.

WHEREFORE, Tampa Electric requests that this Commission consent to the application of the revised Standard Forms as set forth in Exhibit "A".
