## DISCUSSION OF ISSUES

On February 20, 1998, Mr. Williams filed a letter notifying the Commission that he wished to withdraw his protest of the PAA Order. In his letter, Mr. Williams stated that he will forward the \$216.00 for the past due regulatory assessment fees, along with statutory penalties and interest and the \$500 fine amount assessed in Docket No. 971276-TC. Staff is in receipt of the \$716.00. Because Mr. Williams withdrew his protest and no other protests to the PAA Order were filed, there are no issues for the Commission to address in this docket.
