Dear Ms. Bayo:

On behalf of ACC Corp. ("ACC") and US WATS, Inc. ("US WATS") (collectively "the Parties"), this letter is to notify the Commission that the Parties have agreed to a mutual termination of the agreement and plan of merger whereby ACC was to acquire US WATS, a nondominant carrier authorized by the Commission to provide resold intrastate interexchange telecommunications services within the State of Florida. This Commission previously granted the Parties' application for approval of the proposed transaction, by Order issued in Docket No. 971506-TI. Recently, however, the Parties concluded that termination was necessary due to certain delays beyond the Parties' control that have made it impossible to conclude the merger prior to the March 31, 1998 termination date.
