BELLSOUTH TELECOMMUNICATIONS, INC.'S MOTION TO STRIKE PORTIONS OF SUPRA TELECOMMUNICATIONS AND INFORMATION SYSTEMS, INC.'S DIRECT TESTIMONY

BellSouth Telecommunications, Inc., ("BellSouth"), hereby files, pursuant to Rule 25-22.037(2)(b), Florida Administrative Code, its Motion to Strike Portions of Supra Telecommunications and Information Systems, Inc.'s ("Supra") Direct Testimony and, in support thereof, states the following:

1. On March 24, 1998, the Prehearing Officer issued Order No. PSC-98-
