Our review of the application reveals that the minimum filing requirements for this application are incomplete. Additional information is needed to correct those deficiencies. Specifically, the missing information concerns: a) the Department of Environmental Protection's approval date for Zellwood's water treatment facilities was not reported, b) the warranty deed for Zellwood's treatment plant sites did not include an attached document, and c) the title and issuing officer for Zellwood's tariff were not disclosed.

First, under Part III for the water system, the Department of Environmental Protection's approval dates for Zellwood's water treatment plant was not reported. Please identify the approval date for this facility.


