Effective April 30, 1998, OpTex, Inc. (FEIN 31-1342820) will no longer offer interstate or intrastate telecommunications service in the state of Florida. We hereby surrender our authority and certification to provide such services and request the cancellation of our tariff.

We have notified the majority of the 2419 affected customers that reside in your state that our services will no longer be available as of April 1, 1998 (see attached letter), the remaining customers will be notified that service availability will end April 30, 1998. For those accounts that have a credit balance, we will forward a check to the customer after April 30, 1998. OpTex, Inc. has only offered its services in the form of a travel card with a credit line.
