Issue 1: Should the Commission grant WorldCom's and MCI's Joint Motion to Dismiss GTE's Petition on Proposed Agency Action and Request for Section 120.57 Hearing and CWA's Petition to Intervene and Protest of Order No. PSC-98-0125-FOF-TI?

Recommendation: Yes. Taking all the petitioners' allegations as true, GTE and CWA have both failed to sufficiently allege standing to protest approval of the transfer of control of MCI to WorldCom. The Joint Motion to Dismiss GTE's and CWA's protests should, therefore, be granted, and Order No. PSC-98-0125-FOF-TI should be made final and effective as of April 28, 1998.
