MOTION FOR EXTENSION OF TIME

Comes now WorldCom, Inc., for itself and its subsidiary Metropolitan Fiber Systems of Florida, Inc., ("WorldCom"), and requests an extension of time to file a written agreement memorializing the decisions reflected in Order No. PSC-98-0604-FOF-TP. As basis WorldCom would state:

1. Order No. PSC-98-0604-FOF-TP issued April 29, 1998, is a final order of the Commission establishing recurring and nonrecurring charges for certain unbundled network elements ("UNEs"). The UNEs at issue in this proceeding were those for which permanent rates had not been established in the initial arbitration proceedings between these respective parties. of the Order, parties are required to submit written amendments to the existing agreements within 30 days of the Order.

2. On May 14, 1997 BellSouth timely filed a Petition for Reconsideration of portions of Order No. PSC-98-0604-FOF-TP. Although the Order has not been stayed and is effective for all but judicial review, there are issues that are to be resolved. Further, although the parties have been working to prepare an appropriate amendment consistent with the Commission Order, there has not been sufficient opportunity to fully review and conclude the amendment. WorldCom would therefore request additional time to submit the required written amendment.

3. BellSouth is aware of the request for additional time and counsel for BellSouth has authorized WorldCom to represent that they concur in the request.

Based on the foregoing WorldCom requests an additional 30 days to file the written agreement required by Order No. PSC-98-0604-FOF-TP.
