On behalf of Teltrust Communications Services, Inc. ("TCS") and Quest Telecommunications, Inc. ("QTI"), this letter is to notify the Commission of an internal reorganization of Teltrust, Inc. ("Teltrust"),^{1/2} the parent of TCS and the indirect parent of QTI. TCS and QTI are nondominant interexchange carriers authorized to operate as resellers of intrastate interexchange telecommunications services in the State of Florida. This letter is submitted for informational purposes to be included in the appropriate Commission files.

By way of background, Teltrust is a Utah corporation located in Salt Lake City, Utah. Teltrust conducts no business in the State of Florida and holds no authorizations from this Commission. TCS is a Utah corporation located at 6322 South 3000 East, Salt Lake City, Utah 84121. TCS provides resold intrastate interexchange services, including operator assisted services, pursuant to authorization granted in Docket No. 921247-TI. QTI is a Delaware corporation located at 242 Falcon Drive, Forest Park, Georgia 30050. QTI provides resold intrastate interLATA telecommunications services pursuant to authorization granted in Docket No. 930649-TL

Teltrust determined that it could enhance its operational efficiency by creating a new parent company through an internal corporate reorganization ("Reorganization"), which, prompted by important business and financial considerations, was recently completed by Teltrust. In the Reorganization, Teltrust established a new holding company parent, TTST Holdings, Inc.

On April 22, 1998, Teltrust changed its name to Teltrust Holdings, Inc.

("TTST").² TTST is owned by the same entities that owned Teltrust prior to the Reorganization, in proportions identical to these owners' prior respective interest in Teltrust.

Although Teltrust has a new parent, the Reorganization did not alter the ultimate ownership and control of TCS and QTI. TCS and QTI continue to be owned, controlled, and managed by the same entities that owned, controlled, and managed them prior to the Reorganization. The Reorganization, therefore, was entirely *pro forma* in nature and did not, in any way, inconvenience or cause harm to the customers of TCS or QTI. Instead, the Reorganization allowed Teltrust to reduce its operating expenses and realize operational and management efficiencies and other corporate benefits that ultimately will accrue to the benefit of TCS and QTI customers.
