Re: Approval of an Amendment to the Resale Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Basicphone, Inc. pursuant to Sections 251 and 252 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Basicphone, Inc. are submitting to the Florida Public Service Commission their amendment to their negotiated agreement for the purchase of BellSouth's telecommunications services for the purpose of resale to end users by Basicphone, Inc. An initial resale agreement between these two parties is already on file with the Commission. This is the second amendment to this agreement; however, the first amendment pertained only to Tennessee.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the amendment to the negotiated agreement between BellSouth and Basicphone, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience APP \_\_\_\_\_\_and necessity. Both parties aver that neither of these reasons exist as to the agreement they have CAF \_\_\_\_\_\_\_negotiated and therefore, are very hopeful that the Commission shall approve their amendment.

## AMENDMENT TO THE RESALE AGREEMENT BETWEEN BASICPHONE, INC. AND BELLSOUTH TELECOMMUNICATIONS, INC. DATED JANUARY 1, 1998

Pursuant to this Agreement (the "Amendment"), BasicPhone, Inc. ("BasicPhone") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to as the "Parties", hereby agree to amend the Resale Agreement between the Parties dated February 13, 1998 ("Resale Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties and BellSouth hereby covenant and agree as follows:

 The Parties agree that the Operational Support Systems (OSS) Rates Table in Exhibit A of the Resale Agreement shall be modified by deleting "(unlimited end user accounts)" in the charge per order column under OSS Order Charge, and inserting "(per end user account)" below OSS Order Charge as referenced in Attachment 1 of this Amendment.

 All of the other provisions of the Resale Agreement shall remain unchanged and in full force and effect.

 Either or both of the Parties is authorized to submit this Amendment to the appropriate State Public Service Commissions or other Regulatory Agencies for approval subject to Section 252 (e) of the Federal Telecommunications Act of 1996.
