## FIRST AMENDMENT TO MARION COUNTY/DECCA WHOLESALE WATER AND WASTEWATER SUPPLY AGREEMENT CONTRACT NO. 97-1

THIS FIRST AMENDMENT is made and entered into this 212 day of <u>Quit</u>, 1998 by and between DECCA UTILITIES, a Division of DEVELOPMENT & CONSTRUCTION CORPORATION OF AMERICA, a Florida Corporation, whose principal place of business is 8865 Southwest 104th Lanc, Ocala, Florida 32676 (hereinafter "DECCA") and MARION COUNTY, a political subdivision of the State of Florida (hereinafter "COUNTY").

## RECITALS

 On July 15, 1997, COUNTY and DECCA entered into a Wholesale Water and Wastewater Supply Agreement, Contract No. 97-1 (hereinafter "Contract").

 The Contract was specifically made subject to approval by the Florida Public Service Commission (hereinafter "FPSC").

 The PSC has approved the Contract with one modification to which COUNTY and DECCA agree.

ACCORDINGLY, in consideration of the above-stated Recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties, the parties agree as follows: Jun-16-98 09:46A Marion\_County Utilities

SECTION 1. RECITALS. The above Recitals are true and correct, and form a material part of this First Amendment.

SECTION 2. The Contract shall be amended by substituting the following as Section 5 of the Contract:

PAYMENT OF BILLS. DECCA agrees to bill the COUNTY on a monthly basis. The COUNTY agrees to pay for all Water and Wastewater Service received from DECCA and agrees to make payments to DECCA within 20 days from the date the bill is rendered by DECCA. A past due notice will be mailed to the COUNTY after 20 days; if payment has not been received after one hundred ten (110) days from the original bill, service may be discontinued.
