## TRANSCALL'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

Transcall America, d/b/a ATC Long Distance ("Transcall"), hereby requests pursuant to Section 364.183(1), Florida Statutes, and Rule 25-22.006(5), Florida Administrative Code, that certain confidential information associated with the Commission Staff's Audit be treated as confidential information. In support of this Request, Transcall states:

- 1. On June 10, 1998, Transcall representatives met with Kathy Welch of the Commission Staff to conduct an exit interview associated with Audit Control No. 98-071-4-1, which was filed with the Commission Clerk on or about June 15, 1998. In that conference, Ms. Welch provided a copy of the index attached hereto as Attachment "A" as well as each of the documents identified thereon. The documents identified on Attachment "A" were reports generated by the Commission Staff from various original source materials including computer switch tape raw call detail records ("CDR"). In addition, the Commission Staff currently has possession of a number of CDR tapes that were used to generate the Attachment "A" reports.
- 2. The documents identified on Attachment "A" consist of printouts of CDRs, Staff analyses, and a customer listing. These documents contain name, address, and/or telephone numbers of TSI customers. In addition, the CDR tapes contain telephone numbers (both originating and

called numbers) of both TSI and Transcall customers. Transcall believes that section 119.07(3)(r), Florida Statutes, requires it to seek confidential classification of these materials and any CDR tapes held by the Commission Staff. Therefore, pursuant to section 364.183(1), Florida Statutes, and this clair. for confidential classification, Transcall believes that the Commission is required to keep this information exempt from public disclosure under section 119.07(1), Florida Statutes.

- 3. Because these materials were produced by the Commission Staff and because of their volume, Transcall has not prepared highlighted or redacted copies.
- 4. Transcall has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.

WHEREFORE, Transcall requests that the Commission maintain the Attachment "A" materials as confidential, proprietary business information that is not subject to public disclosure.
