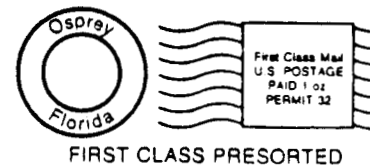
JURISDICTION

NOTICE IS HEREBY GIVEN that the Florida Public Service Commission will hold a hearing regarding the petition of Florida Cities Water Company, (Petitioner) seeking approval of recovery of environmental litigation costs in rates for its North and South Ft. PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the Petition of Florida Cities Water Company for increased water and wastewater rates, and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties in the
