## ANSWER TO COUNTERCLAIM OF BELLSOUTH TELECOMMUNICATIONS, INC.

Easy Cellular Inc. d/b/a TelCom Plus ("Easy Cellular"), in Answer to the Counterclaim of BellSouth Telecommunications, Inc. ("BellSouth"), states:

- 1. Paragraph 1 of the Counterclaim states legal conclusions to which no response is required. Insofar as a response is deemed necessary, Easy Cellular admits that Easy Cellular and BellSouth entered into a resale agreement which was approved by the Florida Public Service Commission (the "Commission") by order on June 12, 1997. Regarding all other factual allegations in Paragraph 1, Easy Cellular is without knowledge or information sufficient to form a belief as to the truth of such allegations in Paragraph 1.
- 2. The allegations in Paragraph 2 of the Counterclaim do not state allegations of fact to which Easy Cellular need respond.
- 3. Easy Cellular admits the Commission has jurisdiction over this dispute as alleged in Paragraph 3 of the Counterclaim.
- 4. Upon information and belief, Easy Cellular admits the allegations in Paragraph 4 of the Counterclaim.
  - 5. Easy Cellular admits the allegations in Paragraph 5 of the Counterclaim.

- 6. Easy Cellular admits that it entered into a resale agreement with BellSouth on March 3, 1997 (the "Agreement"), which broadly stated that Easy Cellular could purchase for resale all of BellSouth's services at a discount off of the retail rate for such services.
  - 7. Easy Cellular admits the allegations in Paragraph 7 of the Counterclaim.
  - 8. Easy Cellular admits the allegations in Paragraph 8 of the Counterclaim.
- 9. Easy Cellular admits that the Agreement in Section VII provides for certain payment and billing arrangements and that BellSouth has provided services to Easy Cellular for resale, but denies the remaining allegations in Paragraph 9 of the Counterclaim.
  - 10. Easy Cellular denies the allegations in Paragraph 10 of the Counterclaim.
  - 11. Easy Cellular denies the allegations in Paragraph 11 of the Counterclaim.
- 12. Easy Cellular admits that it has in its Complaint against BellSouth contested certain rates it charged, but denies the remaining allegations in Paragraph 12, specifically that Easy Cellular does not dispute the remaining amounts that BellSouth alleges are owed to it by Easy Cellular in this Counterclaim.
