After reviewing the application in the above referenced docket, the staff has identified the following deficiencies. Please correct and/or provide additional information as requested.

- As required by Rule 25-30.037(3)(f), Florida Administrative Code (F.A.C.) the utility
 must include a summary of the buyer's financial ability to provide service. The statement, "The
 Buyer's financial ability to provide service is well known to the Commission" is inadequate. Please,
 provide more information of financial ability.
- As required by Rule 25-30.037(3)(k), Florida Administrative Code (F.A.C.) provide the current certificates, so they can be updated with the final order.
- 3. As required by Rule 25-30.037(3)(e), Florida Administrative Code (F.A.C.) provide a statement describing the financing of the purchase. The utility statement that the purchase of stock of Lake Holding, Inc. is a cash transaction financed by a loan from First Union is not sufficient. Please provide the amount financed and the terms of the loan.
- 4. Based on your response in the application to item number 10, is it correct that all regulatory assessment fees for 1998 will be paid by Utilities, Inc. or will the fees be prorated between the buyer and seller? Please clarify.
 - 5. Based on your response in the application to item number 10, is it correct that you will satisfy all refund obligations from the over collection of CIAC gross-up in the pending docket 981070-WS or will the original owners remain responsible?
