

**BellSouth's Response to Supra's Motion for  
Oral Argument and BellSouth's  
Motion for Oral Argument**

BellSouth Telecommunications, Inc. ("BellSouth"), hereby files its  
Response to Supra Telecommunications and Information Systems, Inc.'s  
("Supra") Motion for Oral Argument and BellSouth's Motion for Oral Argument.  
In support thereof, BellSouth states the following:

1. On September 2, 1998, Supra filed its Motion for Oral Argument  
and its Motion to Dismiss BellSouth's Motion for Reconsideration and  
Clarification or Order No. PSC-98-1001-FOF-TP and Motion to Strike BellSouth's  
Answer in Docket No. 980800-TP for Misconduct. On September 10, 1998,  
BellSouth filed its Response and Opposition to Supra's Motion to Dismiss and  
Motion to Strike for Misconduct and its Motion to Strike Supra's Motions as Sham  
Pleadings, Frivolous, Impertinent and Scandalous and For Sanctions.

2. BellSouth agrees that it is within the Commission's discretion to  
grant oral argument pursuant to Rule 25-22.058, Florida Administrative Code.

3. Due to the serious nature of the allegations made by Supra and the request by BellSouth for sanctions, BellSouth agrees that oral argument is appropriate. BellSouth, therefore, also seeks oral argument on its Motion.

WHEREFORE, BellSouth respectfully requests the Commission grant oral argument on Supra's Motions and BellSouth's Motion.
