### INTERMEDIA COMMUNICATIONS INC.'S COMMENTS ON BELLSOUTH'S PETITION FOR WAIVER

Intermedia Communications Inc. (Intermedia) hereby submits in the above-referenced matter its initial comments as requested by the staff.

#### COMMENTS

Intermedia plans discovery BellSouth to serve on Telecommunications, Inc. to more fully develop its position regarding this matter. Intermedia's preliminary comments are set forth below.

The Telecommunications Act of 1996 (Act) in Section 251(c)(6)

requires incumbent local exchange carriers (ILECs) to provide physical collocation unless the carrier demonstrates to the state commission that physical collocation is not practical for technical ACK \_ reasons or because of space limitations. Moreover, the ILEC is **AFA** required to submit to the state commission detailed floor plans or APP diagrams of any premises when the ILEC claims that physical CAF CMU Collocation is not practical because of space limitation. (47 CTR U.S.C. §51.323) EAG LEG Intermedia believes that it is essential to allow competing LIN providers that may seek physical collocation at BellSouth's OPC premises to tour the premises. Allowing competitors to "walk

SEC. WAS through" BellSouth's premises would allow competitors, such as Intermedia, to identify space that could be used for providing physical collocation. Moreover, this Commission would be in a better position to evaluate BellSouth's petition if competitors viewed BellSouth's premises and present their positions to the Commission.

Intermedia respectfully requests that it be permitted to tour BellSouth's facility that is the subject matter of the above-referenced docket, and reserves the right to file additional comments after the walk-through and completion of discovery.
