The utilities collect these fees and relay them to the federal government in return for the Department of Energy's obligation to accept, move, and dispose of spent nuclear fuel. Due to the Department of Energy's default of its contractual and statutory obligation to accept the nuclear waste by January 31, 1998, the Florida Public Service Commission would like to gather information concerning the potential escrow of the funds collected from ratepayers until such time as the Department of Energy begins to move the waste from the state's nuclear power plants.
