ORDER APPROVING AMENDMENT TO EXISTING RESALE AGREEMENT

BY THE COMMISSION:

On July 8, 1998, BellSouth Telecommunications, Inc. (BellSouth) and The Mobile Phone Company, Inc. (The Mobile Phone Company) filed a request for approval of an amendment to the existing resale agreement under 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The amendment to the existing agreement is attached to this Order as Attachment A and incorporated by reference herein.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

This amendment to the existing agreement governs the relationship between the companies regarding local resale and the

exchange of traffic pursuant to 47 U.S.C. § 251. Upon review of the proposed amendment to the existing agreement, we believe that it complies with the Telecommunications Act of 1996; thus, we hereby approve it. BellSouth and The Mobile Phone Company are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions We note that The Mobile Phone Company, of 47 U.S.C. § 252(e). Inc. does not currently hold a Florida certificate to provide exchange telecommunications service, and local alternative alternative local exchange provide it cannot therefore, telecommunications services under this agreement until it obtains a certificate from this Commission.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the amendment to the existing resale agreement between BellSouth Telecommunications, Inc. and The Mobile Phone Company, Inc., as set forth in Attachment A and incorporated by reference in this Order, is hereby approved. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that The Mobile Phone Company, Inc. shall not provide alternative local exchange telecommunications services under this agreement until it obtains a certificate to provide alternative local exchange telecommunications services from this Commission. It is further

ORDERED that this Docket shall be closed.

AMENDMENT TO THE RESALE AGREEMENT BETWEEN THE MOBILE PHONE COMPANY, INC. AND BELLSOUTH TELECOMMUNICATIONS, INC. DATED MARCH 19, 1998

Pursuant to this Agreement (the "Amendment"), The Mobile Phone Company, . Inc. ("MPC") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to as the "Parties", hereby agree to amend the Resale Agreement between the Parties dated March 19, 1998 ("Resale Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree that the Operational Support Systems (OSS) Rates Table in Exhibit A of the Resale Agreement shall be deleted and replaced by the Operational Support Systems (OSS) Rates Table referenced in Exhibit A of Attachment 1 of this Amendment.

2. All of the other provisions of the Resale Agreement shall remain unchanged and in full force and effect.

3. Either or both of the Parties is authorized to submit this Amendment to the appropriate State Public Service Commissions or other Regulatory Agencies for approval subject to Section 252 (e) of the Federal Telecommunications Act of 1996.
