At the October 6, 1998 Agenda Conference, the Commission voted to deny the motion for summary judgment filed by Lake Suzy Utilities, Inc. (Lake Suzy). However, at the agenda conference, counsel for Lake Suzy presented new arguments not previously considered by staff in its analysis and subsequent to the Commission's decision has provided staff with additional information supporting these new arguments. As a result, staff has conducted further research regarding these arguments and has determined that the rationale behind the Commission's decision is incorrect, and, therefore, the Commission should reconsider its decision. Staff is preparing another recommendation for the Commission's consideration at the November 2, 1998 Agenda Conference. Accordingly, staff requests permission to file its recommendation in this matter by noon on Monday, October 25, 1998.
