Thank you for our recent conversations regarding the referenced, and the availability of staff to respond to my inquiries.

I request that you defer that hearing on the referenced scheduled for 11/2, and re-schedule same for hearing in Citrus County. Inasmuch as any rate changes arrived at will inordinately impact citizens in Marion, Citrus, Hernando, Lake and Pasco, I believe 1) the citizens are entitled to be heard on the issue, and 2) Citrus is the most convenient location. The BOCC, Citrus County, is taking up the matter this date, and I have assurances that an appropriate location will be provided.

I further understand that the most recent staff recommendation related to rates is significantly complicated. I believe we are of the same mind that, before citizens are impacted by this government action, they are due an explanation. I believe that explanation should first be offered in connection with public participation, and justified/validated subsequently, if possible, at the evidentiary hearing which I understand will occur in February.

You assistance in arranging this hearing, and counsel, are most appreciated.
