1	PROCEEDINGS
2	(Hearing convened at 9:30 a.m.)
3	COMMISSIONER GARCIA: We'll call the hearing
4	to order. Counsel, will you read the notice.
5	MR. JAEGER: Yes. Pursuant to notice issued
6	November 10th, 1998, this time and place was noticed
7	for a prehearing conference to consider the
8	application of Florida Cities Water Company for
9	increased rates. And it involves the remand from the
10	1st DCA; the only issues left open.
11	COMMISSIONER GARCIA: Okay. Are there any
12	preliminary matters?
13	MR. JAEGER: I think what we need to do is
14	just go straight to the issues wait a minute. I
15	believe Mr. Harold McLean has an ore tenus motion he
16	wants to makes at this time.
17	MR. MCLEAN: I didn't know it was going to
18	be at this time, but I'm happy to make it.
19	MR. JAEGER: Well, I believe you filed your
20	prehearing statement late. And before we can put his
21	positions in we have to I believe we have to say
22	that that's okay.
23	MR. McLEAN: I was going to put my neck on
24	the block and just ask for your indulgence. I was
25	asleep I don't want to give you the real reason,

because it sounds stupider than this. I was simply 1 2 asleep at the switch. It's as simple as that. I 3 wrote it down in the wrong place on my calendar. 4 COMMISSIONER GARCIA: Okay. And that's all right. So we're going to allow him to file late. 5 Is that what --6 7 MR. JAEGER: That's the Staff recommendation, that --8 9 COMMISSIONER GARCIA: Okay. Very good. MR. JAEGER: -- he be --10 MR. MCLEAN: And I might point out, I've 11 12 already filed it. 13 COMMISSIONER GARCIA: Perfect. Very good. 14 So there are no -- there's no issues on the case 15 background, or there's no change on the witness list? 16 MR. JAEGER: The only thing I would change 17 on the order of witnesses would be that the issues -because those numbers are going to change, and so 18 19 we'll just match --20 COMMISSIONER GARCIA: Very good. And so 21 let's do that, and the parties can see you after, and 22 you can make it part of what we do. 23 MR. GATLIN: Commissioner, in the 24 description of the case over on Page 3, I think 25 there's a part missing there. It recites that you

issued the proposed agency action order, and then it 1 2 sort of jumps to the appeal, and I think maybe it 3 ought to be in there what happened between the PAA and 4 the final order. 5 MR. JAEGER: Okay. On the top of Page 3 we talk about the proposed agency action --6 Right. 7 MR. GATLIN: 8 MR. JAEGER: -- was issued. This order was timely protested. Administrative hearing was held on 9 April 24 --10 11 MR. GATLIN: Right. MR. JAEGER: 12 -- 25th. And then subsequent to this hearing the Commission issued its final order 13 on -- however -- I'm not sure what --14 MR. GATLIN: Well, we had no objection to 15 the PAA order. What we appealed was Order 961133, 16 which reduced the rates. 17 MR. JAEGER: What language do you suggest? 18 19 MR. GATLIN: I don't have any -- you're 20 reciting the background of the case, and I think you ought to put it all in there. 21 MR. JAEGER: Well, I say "Subsequent to this 22 hearing, the Commission issued its final order --23 MR. GATLIN: It's no big issue. I mean, if 24 you don't want to put it in there, that's fine. 25

MR. JAEGER: Well, no. I'm just trying to 1 2 figure out what we're missing. PSC -- you know, 3 that's the final order --4 MR. GATLIN: Okay. 5 MR. JAEGER: And then on October 7th --6 COMMISSIONER GARCIA: Mr. Gatlin, if you 7 want to add some wording, think about it as we move this --8 9 MR. GATLIN: Sure. It's no big deal. Ι 10 didn't --11 COMMISSIONER GARCIA: -- and then we'll --12 MR. GATLIN: -- you know, I just thought all the facts ought to be there. 13 14 COMMISSIONER GARCIA: Okay. 15 MR. GATLIN: If Staff is comfortable the way it is, that's fine with me. 16 17 COMMISSIONER GARCIA: All right. We're going to change the -- the parties are going to get 18 together with Mr. Jaeger after, and we're going to put 19 20 on the witness list the issues that they're going to address, because there is going to be some change. 21 22 MR. GATLIN: Sure. 23 COMMISSIONER GARCIA: Issue 1A. MR. JAEGER: I believe that needs to be 24 renumbered just Issue 1, and then also Issue 1B should 25

be Issue 2. 1 2 COMMISSIONER GARCIA: Okay. So we're going 3 to --4 MR. JAEGER: And Issue --COMMISSIONER GARCIA: That was Mr. Gatlin's 5 request, right, that we keep those --6 7 MR. JAEGER: Those are his two issues, and 8 Staff thought we could reach a compromise on how to do those, but he would rather just keep the issues as 9 they are. And it's also the -- Issue 1A comes close 10 11 to what the Court said in its order, so --12 COMMISSIONER GARCIA: Yeah, let's keep it that way. That makes sense. 13 All right. Then Issue --14 15 MR. JAEGER: 1 will be Issue 3. COMMISSIONER GARCIA: Very good. 16 MR. JAEGER: And then on Page 9 --17 COMMISSIONER GARCIA: Well, there's no 18 other -- nobody wants any changes there, right? We're 19 going down this -- so we don't have to come back to 20 21 it; okay? MR. GATLIN: We will have to supply our 22 position on Issue 3, of course. We haven't supplied 23 24 that. Correct. COMMISSIONER GARCIA: 25

1	MR. JAEGER: So we'll get rid of
2	MR. GATLIN: Yes
3	MR. JAEGER: compromise Issue 1 will be
4	totally deleted.
5	COMMISSIONER GARCIA: Totally deleted. Then
6	Issue 2 will be Issue 4?
7	MR. JAEGER: Issue 4.
8	COMMISSIONER GARCIA: Issue
9	MR. JAEGER: And I think Mr. Gatlin wanted
10	to change that wording slightly. It's "What is the
11	appropriate provision for rate case expense for
12	reopening the record?" And I think what we really
13	need to say is "What is the appropriate provision for
14	rate case expense since the remand of the Commission's
15	final order by the 1st DCA?"
16	Is that correct, Ken?
17	MR. GATLIN: Well, if we have another issue
18	as to what the rate case expense was during the
19	appellate process
20	MR. JAEGER: Okay. Well
21	MR. GATLIN: because we would
22	MR. JAEGER: that's the next issue.
23	MR. GATLIN: All right. Okay.
24	MR. JAEGER: Let's go to Issue 3 on Page 10,
25	and it says "What is the appropriate provision for

1 appellate nonlegal rate case expense?" Do you have 2 any problem with that issue?

3	MR. GATLIN: No. And that would be that
4	number, to make it clear, as I understand it is and
5	I think you understand this is part of the amount
6	of 229,399 let me start over \$229,399, which is
7	the total rate case expenses we're asking for in this
8	case. And as I understand it, what you want is a
9	breakout of rate cases expense that was incurred
10	during the appellate process.
11	MR. JAEGER: Yes.
12	MR. GATLIN: Okay.
13	MR. MCLEAN: That was Issue 5 you're
14	changing that
15	COMMISSIONER GARCIA: Right. Issue 3
16	becomes Issue 5. Issue 3A is we're going to take
17	that one out. Issue 4 becomes Issue 6. Issue 5
18	becomes Issue 7. And I guess the utility will also
19	have to file a position there as well as in Issue 5.
20	Issue 6 becomes Issue 8, and Issue 7 becomes
21	Issue 9.
22	MR. MCLEAN: My version has as its last
23	issue, 3A on Page 10. Maybe I don't have an
24	updated (Document handed to Mr. McLean.)
25	COMMISSIONER GARCIA: Mr. McLean, do you

1 need a few minutes to go through it or --2 MR. MCLEAN: No, sir. Those are boilerplate ones I'm fairly familiar with. 3 COMMISSIONER GARCIA: Okay. 4 5 MR. MCLEAN: Thank you, sir. 6 COMMISSIONER GARCIA: All right, is there 7 any correction to the exhibit list? 8 MR. GATLIN: Commissioner, I assume we'll get a redraft of what's happened today, and we'll 9 check it to make sure everything is correct. 10 COMMISSIONER GARCIA: Mr. Jaeger, on Page 13 11 12 when you order by Commissioner Joe A. Garcia, drop the "A" if you can, since we're already informal with 13 "Joe". 14 MR. JAEGER: And I'll put in the ore tenus 15 motion was granted. 16 17 COMMISSIONER GARCIA: Was granted. Is that --18 19 MR. GATLIN: I have just a couple items. Ι 20 have a witness, Mr. Harley Young, who is employed by the Florida Department of Environmental Protection, 21 and I need to set kind of a parameter if the parties 22 would agree as to when I can produce him, preferably 23 on the afternoon of the 8th sometime. 24 25 COMMISSIONER GARCIA: Okay.

MR. McLEAN: No objection. 1 MR. JAEGER: No objection. 2 COMMISSIONER GARCIA: Okay. 3 4 MR. GATLIN: The other item is, I assume 5 that what goes on in this part of the case is in addition to what's already of record. This is in 6 7 addition to the existing record. The existing record is still the record. 8 9 COMMISSIONER GARCIA: Right. 10 MR. GATLIN: As I understand. 11 MR. JAEGER: That's correct. 12 MR. GATLIN: And I would like to file an 13 update on the rate case expenses, to put some of the projections, get the actual numbers. I can do it 14 15 next -- by Monday. COMMISSIONER GARCIA: Is that enough time 16 17 for you Mr. McLean? MR. McLEAN: Yes, that's fine. 18 MR. JAEGER: That will be fine. That's the 19 23rd? 20 MR. GATLIN: 21 Yes. 22 MR. JAEGER: I want to make sure we have issue -- the renumbered Issue 4 correct, Mr. Gatlin. 23 24 I want to make sure we are in total agreement on that 25 issue. And we have "What is the appropriate provision

for rate case expense for reopening the record?" And 1 maybe it should be phrased -- and we said "since the 2 remand of the 1st DCA." 3 MR. GATLIN: Right. So we'll have two parts 4 5 of rate case expense. 6 MR. JAEGER: Yes. 7 MR. GATLIN: Okay. One that went on during the appellate process and, two, the part that has 8 9 occurred since the remand. 10 MR. JAEGER: Right. 11 COMMISSIONER GARCIA: Very well. Anything 12 else? 13 MR. JAEGER: Okay. How soon can we get the 14 positions for these issues Harold? 15 MR. MCLEAN: As quick as you get us the 16 numbers correctly, I can knock it out within an hour 17 of when I get them. I don't know -- maybe I can get 18 with you after this proceeding and get the numbers correctly and then I can get them to you as soon as I 19 20 get back to the office. 21 MR. JAEGER: Okay. 22 MR. GATLIN: It would be helpful, if it's possible, if you could just do a redraft now with the 23 24 way it looks or supposed to look from the final form. 25 I think we can deal --

1 COMMISSIONER GARCIA: I think we can do that 2 if --3 MR. GATLIN: -- with the issues a lot 4 better. 5 MR. MCLEAN: Agreed. COMMISSIONER GARCIA: Probably do that by 6 7 noon today and just give them out. MR. JAEGER: I'll get it done by maybe a 8 9 little bit after lunch. 10 MR. MCLEAN: Just fax them over, and I'll fax you the answers back. 11 12 MR. JAEGER: Okay. And I'm not sure if we 13 ever took appearances. I don't know if we needed to 14 do --15 COMMISSIONER GARCIA: Okay. Well, let's, 16 just in case, take appearances. 17 MR. GATLIN: I'm B. Kenneth Gatlin 18 representing the applicant in this case. 19 MR. McLEAN: Harold McLean of the Office of 20 Public Counsel representing the citizens of the state of Florida. 21 22 MR. JAEGER: Ralph R. Jaeger on behalf of 23 Commission Staff. 24 COMMISSIONER GARCIA: Okay. Very good. And 25 then we're going to have this then finished out by
