

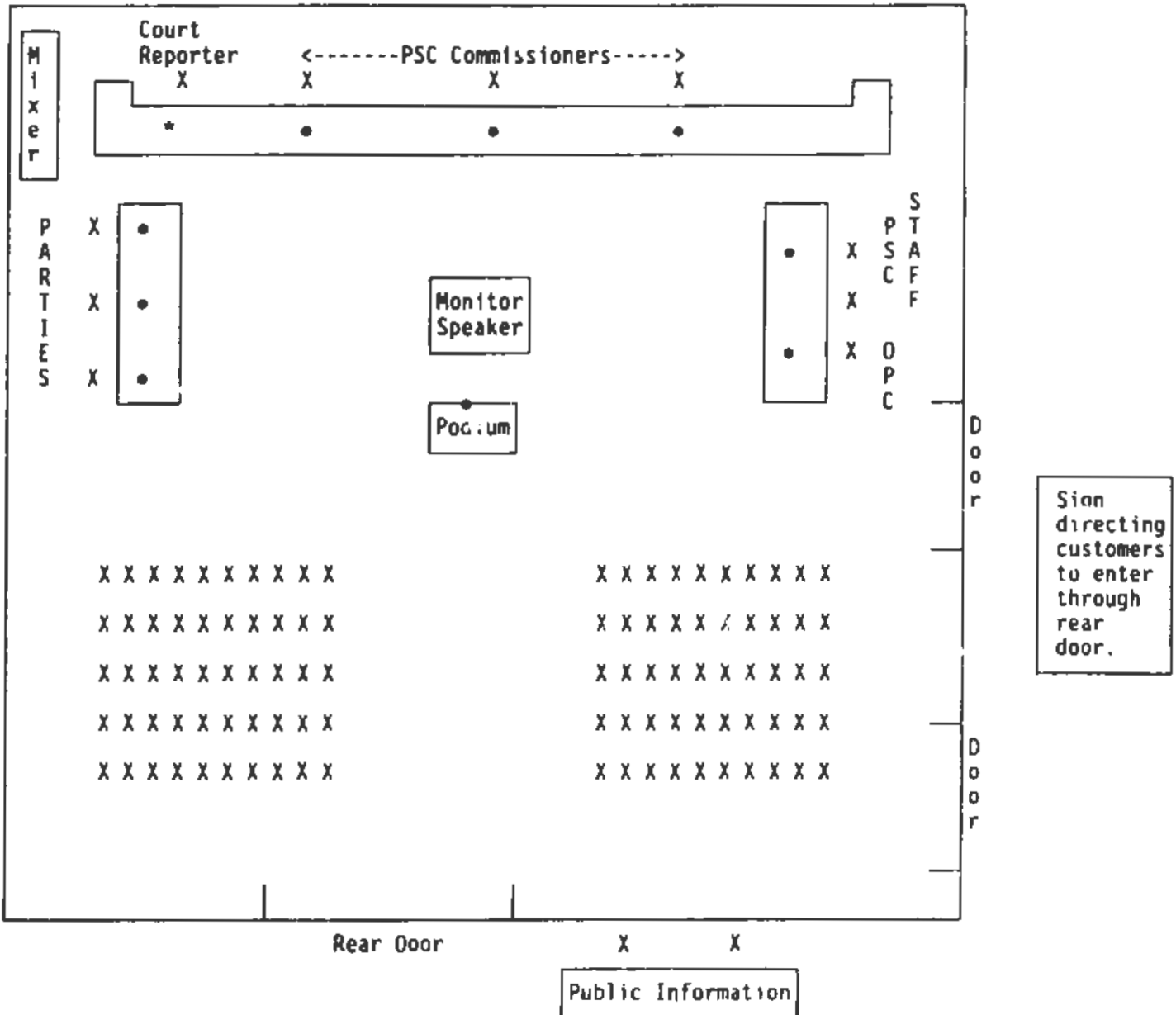

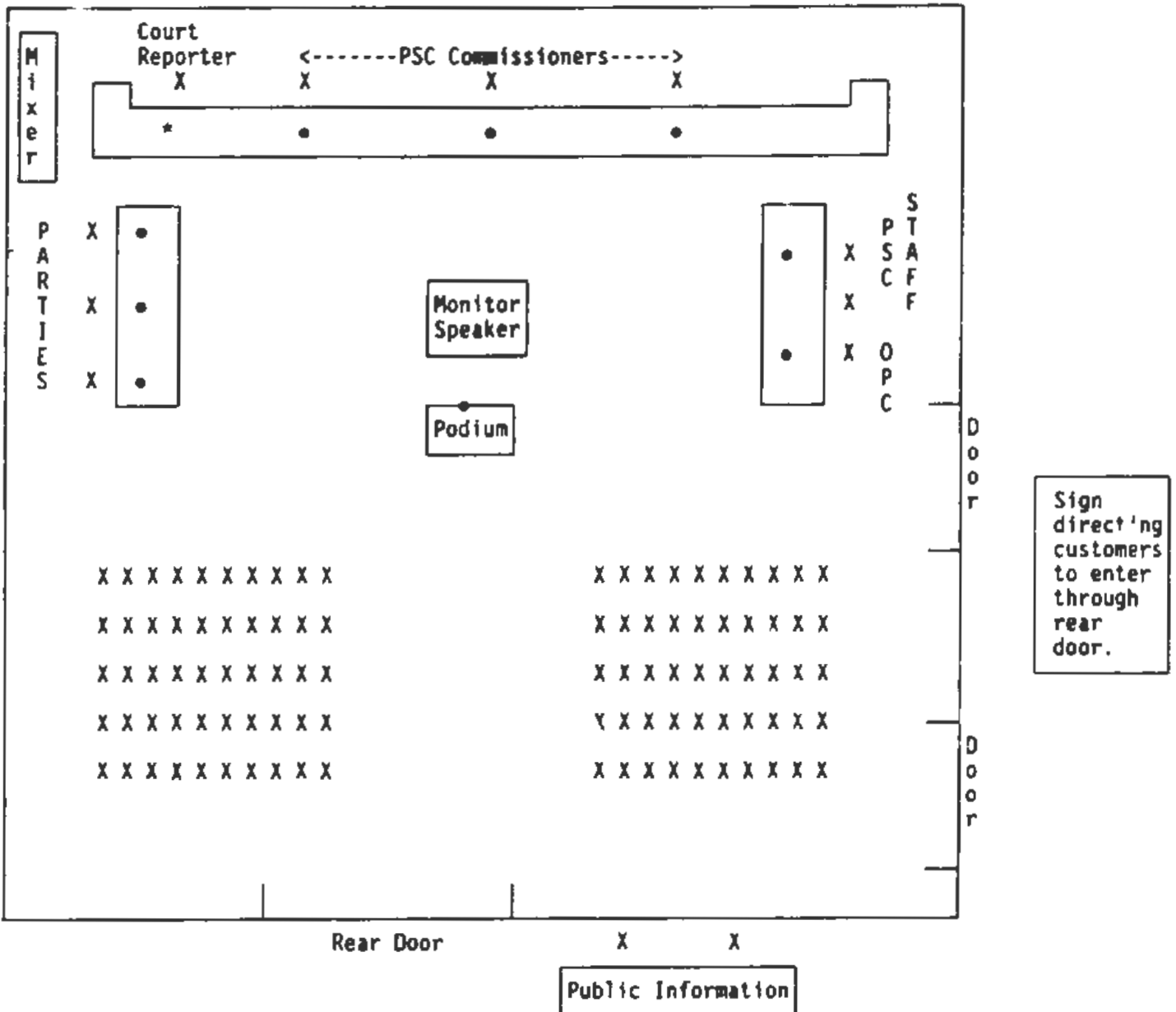

Please refer to the news article published in The Ledger, Sunday, January 19, 1997 by Lonnie Brown. In that article he refers to the area of Polk County known as the Ridge. Haines City is in this area discussed in the article. Mr. Brown indicated that computer owners in this area have been unable to log on-line with major providers such as America-on-Line unless they pay an extra fee or toll charges. He continues that, before December 1996, there were over 7,000 computer users in this area of the Ridge. I have written letters to each of the major providers concerning this problem of "being out of the area". A copy of a letter from Prodigy is included wherein they confirm that we are unable to directly access their service without extra charges.

I use a beeper from MobileComm, a BellSouth Company, for business matters. Even though they are one of the largest communication providers, my service can not be called direct from my home with out long-distance charges because the nearest MobileComm beeper number is out of Lakeland. It forces an extra expense should my family need to contact me when I am away from home.

Last year, Congress adopted the Telecommunications Act of 1996. Section 207 directed the Federal Communications Commission to adopt rules that permit every home in the United States the access to TV and communications even if they were prohibited by existing covenants and restrictions. While this Section does not directly address the phone coverage that is under consideration by this Commission, the intent is strong in that Congress wants all citizens to have the right to open communications.

Under the current service, we have been denied direct access to our County Government, services and businesses of our choice, and communications via our computer without paying extra service costs. Even with the plan under proposed today, we would have the service at an extra cost but more reasonable charges. I suggest that you consider the plan to extend the service to Bartow and Lakeland as an extension of the current service from the Ridge.

**E**verybody's in touch instantly, it seems. Cellular telephones allow anyone to be contacted almost anywhere. Computers can act as answering machines, then send a page out to their owners, notifying the com-

promotional disks], but there is no access terminal other than their service line.

These service lines are 800 numbers, and while they are "toll-free" on the monthly telephone bill, the online services bill the users' accounts for a fee for connecting through them—typically \$3 to \$5 an hour.

That's nice to have if you're traveling and are in an area that doesn't have a local connect number. But if you're a full-time resident without a local number, connecting frequently at \$3 an hour—plus paying a monthly bill to maintain an online account—can become expensive.

There is no local call number for

like geography. It stretches from Haine, City in the northeast corner of the county, east of Winter Haven to Lake Wales—which calls itself the "Crown Jewel of the Ridge" and Frostproof.

Did you know that 6500 years ago when Florida was mostly underwater, those white-sand outcroppings you see as you drive along the Ridge were Florida beaches and sandbars? That was back in prehistoric days.

Many computer users who live on the Ridge argue that the telephone

these online services on the Ridge, said Myers. He also pointed out that many of the larger Internet service providers, including AT&T and GTE, do not have a local number to connect.

Some Internet providers, like Cybergate and Florida Online, do realize that there is a market on the Ridge and have established numbers in Winter Haven that are local calls from most of the Ridge.

While AOL does not have a local number for Ridge users, a company spokesman noted that AOL offers a plan to allow users who have an Internet provider to connect through it to AOL at a reduced monthly rate of \$9.95.

service—at least as far as online providers are concerned—is still frozen in prehistoric times.

Over the years, the thousands of them who live there have complained about having to call long-distance numbers to connect with services—America Online, Prodigy, CompuServe and others—that nearly everyone else in the county can get by calling a local number.

Harry Myers is one of them. "Lakeland is long distance for all of us," wrote Myers in a recent e-mail. "We estimate there are [before Christmas] over 7,000 computer users on the Ridge. My point: AOL and others want to encourage us to try [the service by sending

It's not hard to do, but some users would rather connect directly to a national online service.

And while we're at it, any local number that's added to the Ridge should be a separate number that serves the area—not simply one that switches the call to a router in Lakeland or Winter Haven that is already handling calls for that service area. Those are already busy enough.

Thank you for your letter to Paul Delacey regarding Prodigy access in your area.

We sincerely regret you are currently unable to access Prodigy with a local telephone number. Prodigy is available as a local call to a large majority of our members. We would like to offer local access numbers to all of our current and potential members, and we are continually adding or updating our access numbers.

Each of our access numbers requires a significant investment by Prodigy in leased telephone lines and acquisition of an access site. For these reasons we must be prudent when selecting sites. Currently we use Census Bureau population density statistics, as well as independent market research data for PC market penetration. Our site selections are the result of analyzing these studies. This results in a small percentage of American households who are currently able to access only through a toll call. Many people are active members even under these circumstances, by using off-peak periods with lower toll charges.

It may interest you to know Prodigy is currently negotiating with local phone companies around the nation to make the service more accessible to our members. In this way, the vast majority of our members will not have to make a toll call. Thanks again for writing and for your interest in the Prodigy Service.

Due to your letter, we have requested a local number in the Polk County area, specifically The Ridge.

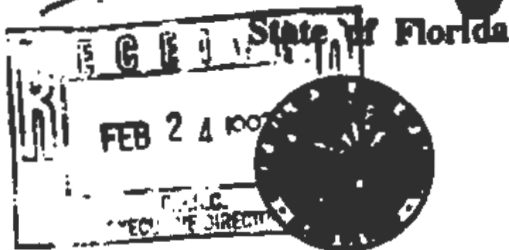

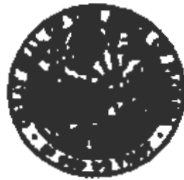
