## TAMPA ELECTRIC COMPANY'S MOTION FOR EXTENSION OF TIME TO FILE NON-FIRM ELECTRIC SERVICE REPORT

Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Fla. Admin. Code Rule 28-106.204 and 25-6.0438, files this its Motion for a four day extension of time within which to file the company's Non-Firm Electric Service Report and, as grounds therefor, says:

- Fla. Admin. Code Rule 25-6.0438(7) requires utilities offering non-firm electric service to submit to the Commission a report each January 1 and July 1 detailing the type of nonfirm service offered and showing the amount of non-firm load on the utility's system along with other information relative to non-firm load.
- Tampa Electric is in the process of finalizing its January 1, 1999 report (technically due January 4) and is in need of a four day extension of time through January 8 within which to complete this process and verify the results.
- The requested extension of time should have no adverse impact on anyone and will enable Tampa Electric to ensure the accuracy of its non-firm load report.
- 4. This is an undocketed reporting requirement. Consequently, there are no parties with whom the company must confer regarding the requested extension of time.

WHEREFORE, Tampa Electric Company submits the foregoing as its motion for a four day extension of time, through January 8, 1999, within which to file its non-firm electric report.
