

ORDER GRANTING PAY TELEPHONE CERTIFICATES

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Each of the entities listed in the caption of this Order have filed applications for certificates to provide pay telephone service. These applications were filed pursuant to Section 364.3375, Florida Statutes, which provides that no person may provide pay telephone service without first obtaining from this Commission a certificate authorizing the provision of such service, in accordance with Section 364.335, Florida Statutes, and Rule 25-24.511, Florida Administrative Code.

Re: Confusion Regarding Company Name

Dear Mr. Williams:

The Commission was contacted by Mr. George Louis, representing the City of Ormond Beach, seeking verification that the Public Payphone Company is authorized to provide pay telephone services within Florida. Because the name "Public Payphone Company" is not in our records, I could only advise him that the Public Payphone Company was not authorized to provide pay telephone services. Mr Louis did not have a person's name, only the company name. I have no way of associating Glenn Williams with the Public Payphone Company. As a result of you returning my phone call and supplying more information, I was able to verify that certificate number 4145 was issued to Glenn Williams. I have notified Mr. Louis that Glenn Williams has a valid pay telephone certificate.

I have verified that the Public Payphone Company is a fictitious name registered with Florida's Secretary of State to Glenn L. Williams. Also, when I called your telephone number (904) 767-6067, the recorded message given was that I had reached the Public Payphone Company.

I have no knowledge regarding the placarded information you provide on your pay telephone stations. However, it does appear to me that you are using the fictitious name "Public Payphone Company" as recognition of your pay telephone company. For your information, Rule 25-24.515 (5), Florida Administrative Code provides that each telephone station shall be equipped with a legible sign, card, or plate of reasonable permanence that identifies the name of the certificate holder. In this case, the name of the certificate holder is Glenn Williams. Thus, the telephone station placards should display "Glenn Williams".


Understandably, many individuals do not care to have their names on pay telephone station placards. The question for you is what name do you display on your pay telephone stations? If it is Glenn Williams, then you are in compliance with Rule 25-24.515(5), Florida Administrative Code. If you display Public Payphone Company, then you would be in violation of the rule.

Should you desire to use the fictitious name Public Payphone Company, there is a way this can be accomplished. Simply submit a letter requesting a name change on your pay telephone certificate, along with a copy of the fictitious name registration document from the Secretary of State. Your request should identify the certificate number (4145), the company code (TF-347), the current certificated name (Glenn Williams) and the new name you would like to have on the certificate (Glenn L. Williams d/b/a Public Payphone Company). Commission rules allow this type of name change request at no cost to you.

Based on the confusion experienced by both your potential client and myself, plus the potential of a rules violation, you might consider submitting a request to change the certificated name. You may submit your request directly to me at the address shown on this letter. 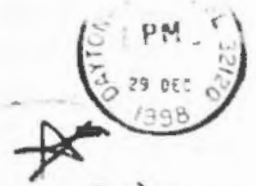
