STANDING

Coalition for Responsible Econlockhatchee Development, Inc. (C-RED) is a Florida not-for profit corporation serving the public interest through the promotion of responsible development within the Econlockhatchee River Basin, which includes the Chuluota area.

A significant number of our members use Florida Water Services, Inc. (FWS) as the provider for their potable water needs.

The expansion of FSW's service area represents the impact of a service which supports and demands development into "an area with specific rural character rather than an area anticipated to be urbanized", that is, an area of rural land use designations. This will stimulate growth and development beyond that allowed by the Seminole County Comprehensive Plan and will contribute to urban sprawl, thereby violating the basic purpose of C-RED of responsible development directly affecting our membership.
