BELLSOUTH TELECOMMUNICATIONS, INC., ("BellSouth", or "Company") hereby files its interim report regarding the calculation of amounts ordered to be refunded to customers during January, 1999.

1. By Order No. PSC-97-0488-FOF-TL, dated April 28, 1997, the Florida Public Service Commission (the "Commission") ordered BellSouth to refund to BellSouth's customers monies related to rate regrouping for Jensen Beach, Pensacola, West Palm Beach and Yulee. The Order also required BellSouth file with the Commission a report describing the refund calculation on a per line basis as well as the back-up sheets to that calculation.
