NOTICE ACKNOWLEDGING MOTION FOR POSTPONEMENT OF CASE SCHEDULE IS MOOT


Now comes Florida Water Services Corporation ("Florida Water") by and through its undersigned counsel, and hereby acknowledges that the Stipulated Motion for Postponement of Case Schedule filed in this docket on July 30, 1998, is moot. In support thereof Florida Water states as follows:

1. The Prehearing Order in this docket was issued on July 8, 1998. Pursuant to said Order, Florida Water's testimony was due on August 12, 1998; Intervenor's testimony was due on September 11, 1998; Staff's testimony was due on October 13, 1998; Rebuttal Testimony was due on November 13, 1998; Prehearing Statement were due on December 12, 1998 and hearings were scheduled for January 26 - 28, 1999.
2. On September 11, 1998, Marion County filed a Stipulated Agreement between Marion County and Florida Water which resolved the parties differences through a territorial settlement.
3. On September 11, 1998, Marion County filed its Notice of Withdrawal of Protest for Florida Water's territory amendment.
4. On January 20, 1999, Florida Water filed a revised legal description reflecting the

settlement agreement between Florida Water and Marion County along with maps and new tariff sheets reflecting the same.

WHEREFORE, for the foregoing reasons, Florida Water respectfully requests that the Prehearing Officer find that the Stipulated Motion for Postponement of Case Schedule moot.
