Issue 1: Should the Commission grant the request for voluntary cancellation submitted by Patricia Deihl?

Recommendation: No.

Issue 2: Should the Commission impose a \$500 fine or cancel the pay telephone certificate of Patricia Deihl for apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees, effective December 31, 1997?

Recommendation: Yes. The Commission should impose a \$500 fine or cancel Ms. Deihl's certificate effective December 31, 1997, if the fine and the regulatory assessment fees, including statutory penalties and interest, are not received by the Commission within 5 business days after the conclusion of the 21-day protest period. The fine should be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section

364.285(1), Florida Statutes. If the Commission's order is not protested and the fines and the regulatory assessment fees, including statutory penalties and interest, are not received, the certificate should be canceled.

Issue 3: Should the Commission fine Patricia Deihl \$10,000 for apparent violation of Rule 25-4.043, Florida Administrative Code, Response to Commission Staff Inquiries?

Recommendation: The Commission should impose a \$10,000 fine for failure to comply with Rule 25-4.043, Florida Administrative Code. The fine should be remitted within 5 business days after the conclusion of the 21-day protest period. The fine should be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the Commission's order is not protested and the fine is not received, it should be forwarded to the Office of the Comptroller for collection.

Issue 4: Should this docket be closed?

Recommendation: If no person whose substantial interests are affected files a protest within 21 days of the issuance date of the order, the order will become final. Upon payment of the fines and fees, or cancellation of the certificate, this docket should be closed.
