
Dear Mr. lowe,

It has come to my attention that you have sent notice to a number of residents of Buccaneer Estates. These residents had filed an “objection” with your office, in regard to a hearing in the above captioned matter. On or about December 15, 1998, I also filed an objection with the Director of the Division of Records and Reporting, but unlike the residents mentioned above, I have not received notice.

In your letter, dated January 13, 1999, to the residents who have filed an objection, you advised these residents that they had until January 25, 1999 to advise your office as to “... *what you intend to do in this regard.*” Please be advised that of this date, January 21, 1999, I have not received a notice from your office; therefore, I am concerned that I may not receive timely notice from your office, which may prejudice my standing and my right to present my concerns and objections in this matter.

Since, I have not received timely notice as of this date, for the record, I intend to provide written and oral testimony in any and all matters within the jurisdiction of this Commission. I also reserve the right to file a civil action in either a Florida Circuit Court, pursuant to Section 501.2091 of the Florida State Statutes, or in the Federal District Court.
