# ORDER CORRECTING ORDER NO. PSC-98-1752-FOF-WU TO REFLECT ACCURATE TERRITORY DESCRIPTION AND CLOSING DOCKET

BY THE COMMISSION:

On April 20, 1998, Alturas Water Works (Alturas) submitted an application for transfer of water facilities to Keen Sales, Rentals and Utilities, Inc., (Keen). The transfer was approved by Order No. PSC-98-1752-FOF-WU, issued on December 22, 1998, in Docket No. 980536-WU. That Order also canceled Certificate No. 591-W, held by Alturas, amended Certificate No. 582-W, held by Keen, to include the territory served by Alturas, and closed the docket.

Subsequent to issuance of the Order, it was discovered that there was an error in the first line of the territory description shown on Attachment A of Order No. PSC-98-1752-FOF-WU. Docket No. 980536-WU was reopened so that the territory could be corrected.

The word "South" was inadvertently omitted from the first line of the territory description. The first line of the description reads as follows:

In Township 30, Range 26 East, Section 16, Polk County, Florida

The first line should read:

In Township 30 South, Range 26 East, Section 16, Polk County, Florida

The correction does not affect any customers or add any additional area to Keen's certificated territory. The mistake appears to be a scrivener's error. Accordingly, we find it appropriate to correct Order No. PSC-98-1752-FOF-WU to reflect the correct territory description as shown on Attachment A of this Order, which by reference is incorporated herein. The utility provided tariff sheets reflecting the correct description.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request of Keen Sales, Rentals and Utilities, Inc., 685 Dyson Road, Haines City, Florida 33844, to correct the scrivener's error in the territory description approved by Order No. PSC-98-1752-FOF-WU is hereby granted. The Order is hereby corrected to reflect the correct territory description as shown on Attachment A of this Order, which by reference is incorporated herein. It is further

ORDERED that Docket No. 980536-WU is hereby closed.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and reporting and filing a copy of the notice This of appeal and the filing fee with the appropriate court. filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
