ORDER AMENDING CERTIFICATES TO INCLUDE ADDITIONAL TERRITORY AND CLOSING DOCKET

BY THE COMMISSION:

Background

Florida Cities Water Company - Barefoot Bay Division (FCWC or utility) provides water and wastewater service in Brevard County and serves approximately 4,721 water and 4,579 wastewater customers. Florida Cities Water Company includes the Barefoot Bay; Golden Gate and Lee County Divisions. The annual report for 1997 shows that the annual operating revenue for the Barefoot Bay system is \$2,593,000 and the net operating income is \$517,000. FCWC is a Class A utility.

On October 20, 1998, the utility applied for an amendment of Water Certificate No. 7-W and Wastewater Certificate No. 3-S in Brevard County to include an area requested by Avatar Properties, Inc. on behalf of Crystal Bay development (Area A), and some residential customers (Area B) who have their own wells and septic tanks. The utility anticipates serving about 81 equivalent residential connections with water and wastewater service in this area.

Application

The application is in compliance with the governing statute, Section 367.045, Florida Statutes, and other pertinent statutes and administrative rules concerning an application for amendment of certificate. The application contains a check in the amount of \$200 which is the correct filing fee pursuant to Rule 25-30.020, Florida Administrative Code. The applicant has provided evidence, in the form of a warranty deed, that the utility owns the land upon

which the utility's facilities are located as required by Rule 25-30.036(3)(d), Florida Administrative Code.

Adequate service territory maps and a territory description have been provided as prescribed by Rule 25-30.036(3)(e), and (i), Florida Administrative Code. Descriptions of FCWC's territory are appended to this Order as Attachments A and B. Attachment A is a description the additional territory sought by the utility. Attachment B is a complete rewritten description of the utility's existing territory. The rewritten description includes the area granted in Orders Nos. 5016, 9526, PSC-97-0141-FOF-WS - which corrected the description contained in Order No. 5016 - and the new area in this docket. The utility has submitted an affidavit consistent with Section 367.045(2)(d), Florida Statutes, that it has tariffs and annual reports on file with us. In addition, the application contains proof of compliance with the noticing provisions set forth in Rule 25-30.030, Florida Administrative Code. No objections to the application have been received and the time for such has expired. The local planning agency was provided notice of the application and did not file a protest to the amendment. The Department of Community Affairs states that it has identified any growth management concerns related to consistency with the Brevard County Comprehensive Plan. utility states that the provision of service will be consistent with the utility section of the local comprehensive plan.

FCWC has the financial and technical ability to continue to provide service to the customers. FWSC is a large, multi-county operation in the State of Florida, and has been in the water and wastewater utility business since 1965. Water service will be provided by the utility's 1.0 million gallons per day (mgd) water treatment plant. The average current flows are 44%, or .44 mgd, of the water treatment plant capacity, and the peak day flow is 71%, or .71 mgd. There is a total of 800,000 gallons of storage to handle the peak demand. The extension will add an average daily demand of .020 mgd and a peak demand of .031 mgd. There appears to be sufficient water treatment capacity to serve the proposed territorial extension. Wastewater service will be provided by the utility's .75 mgd wastewater treatment plant. Current average daily flows for the twelve-month period are at .546 mgd, with flows for the peak day at 1.581 mgd. The plant was designed with a 3.0 hydraulic peaking factor. The peak flow was handled without any degradation in the quality of service. This extension will add an average daily flow of .020 mgd and a peak day flow of .053 mgd. The developer will provide reuse by taking back and reusing at

least the same amount of wastewater generated by the parcel, as reclaimed water. The developer (Area A) will construct all necessary reclaimed water mains and dedicate them to Florida Cities.

It appears that the utility has sufficient wastewater treatment plant capacity to serve the development. The utility currently disposes its effluent on a 40-acre sprayfield owned by the utility and leased by H & S Groves, a sod farm and orange grove. FCWC also disposes its effluent on the Barefoot Bay Golf Course. The water system for Area A will connect to an existing 6-inch main at Midway Street and Floral Drive. The wastewater collection system for the Crystal Bay Development will be connected directly to the Barefoot Bay Advanced Wastewater Treatment Plant, thereby creating a new wastewater system. The water and wastewater lines for Area B will be extensions to existing line. According to the Department of Environmental Protection, there are no outstanding notices of violation regarding this utility.

Based on the above information, we find that it is in the public interest to grant the application of Florida Cities Water Company - Barefoot Bay Division, for amendment of Water Certificate No. 7-W and Wastewater Certificate No. 3-S. The utility has returned the certificates for entry of the additional territory and filed revised tariff sheets which reflect the amended territory description.

Rates and Charges

FCWC's water and wastewater rates were last changed pursuant to a rate reduction following four year amortization of rate case expense on February 1, 1999, as indicated in Commission File Number WS-98-0235. This reduction was required by Order No. PSC-95-0039-FOF-WU, issued January 10, 1995 in Docket No. 940687-WU, which approved increased rates and charges for FCWC. We approved FCWC's most recent rate increase by Order No. PSC-97-0516-FOF-WU, issued May 5, 1997 in Docket No. 951258-WS. Service availability charges for water and wastewater became effective on September 29, 1994 by Order No. PSC-94-0961-FOF-WS in Docket No. 940106-WS, issued August 8, 1994. We approved an increase in FCWC's service availability charges for wastewater by Order No. PSC-96-0935-FOF-SU, issued July 18, 1996 in Docket No. 951311-SU. The utility shall continue to charge its existing rates and charges until authorized to change by this Commission in a subsequent proceeding.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Water Certificate No. 7-W and Wastewater Certificate No. 3-S, held by Florida Cities Water Company - Barefoot Bay Division, 931 Barefoot Boulevard, Suite 2, Barefoot Bay, Florida 32976, are hereby amended to include the territory described in Attachments A and B of this Order. It is further

ORDERED that Attachments A and B are incorporated herein by reference. It is further

ORDERED that Florida Cities Water Company - Barefoot Bay Division shall charge the customers in the territory added herein the rates and charges approved in its tariff until authorized to change by this Commission. It is further

ORDERED that this docket is hereby closed.

Extension Area A

The intersection of the North line of the Southeast 1/4 of Section 3 (also the North line of the South 1/2 of Section 3), Township 30 South, Range 38 East and the Westerly right of way line of the Florida East Coast Railroad (100 foot Right of Way width) describes the Point of Beginning.

A portion of Sections 3, 9, 10, 11, 15 and 16, Township 30 South, Range 38 East, Brevard County, Florida, being more particularly described as follows:
